## EXAM FORMAT AND DURATION

## PASSING CRITERIA

TO PASS EACH PART OF THE EXAM, CANDIDATES MUST SCORE AT LEAST 360 OUT OF 500 POINTS. THE SCORING SYSTEM COMBINES THE RESULTS OF MULTIPLE-CHOICE QUESTIONS AND ESSAYS, WITH THE ESSAYS DESIGNED TO TEST THE APPLICATION OF KNOWLEDGE IN REAL-WORLD SCENARIOS.
